PERSONAL GUARANTY

THIS PERSONAL GUARANTY is given by the undersigned (the "Guarantor") to Nevada Sea Food Company, a Nevada Corporation, as of the date first above written. In consideration of Seller entering into the Agreement with Buyer and other good and valuable consideration, Guarantor agrees as follows:

1. **Guaranty.** The Guarantor hereby unconditionally guarantees the full faithful performance by Buyer of all the terms and conditions of the Agreement. Guarantor shall pay, reimburse, and indemnify Seller all damages, costs expenses, attorney fees, and other liabilities arising or resulting from Buyer's failure to perform or satisfy the terms of the Agreement. Guarantor's liability is direct, immediate, absolute, continuing, unconditional, and unlimited. Seller shall not be required to pursue any remedies against Buyer. In the event of a default under the Agreement or related documents by Buyer. Guarantor shall not be discharged or released by reason of the discharge or release of the Buyer for any reason, including any Bankruptcy proceedings. Guarantor assumes all reasonability for being and keeping informed of Buyer's financial condition and assets, and of all other circumstances bearing upon the risk of nonperformance by Buyer under the Agreement.
2. **Waiver of Notices.** Without notice to or further assent from Guarantor, Seller may: waive or modify any term or condition of the Agreement or related obligation of the Buyer; or compromise, settle, or extend the time of payment of any amount due from Buyer or the time of performance if any obligation of Buyer. Seller may take these actions without discharging or otherwise affecting Guarantor's obligations hereunder.
3. **Binding Effect.** This guaranty is binding upon Guarantor, his/her legal representatives and assigns, and is binding upon and shall inure to the benefit of Seller, its successors and assigns.
4. **Modifications.** This guaranty may be amended only by a writing signed by both Guarantor and Seller.
5. **Governing Law.** This Guaranty shall be governed by and construed according to the laws of the State of Nevada. Any legal proceeding or litigation involving the interpretation, construction, or enforcement
